PRIVACY POLICY

August & Joseph, LLC appreciates your interest in our Site. This Privacy Policy (“Policy”) is effective as of August 1, 2015. It applies and is limited to treatment of information that is collected via this Site or used as a result of this Site. Your prior activities on the Site may have been governed by an earlier version of this Policy.

From time to time, we may use your information for new, unanticipated uses not previously disclosed in our Policy. If our information practices change materially at some time in the future, we will post the changes to our Site and revise our Policy accordingly. In addition, if we have collected personally-identifying information from you, we will notify you about the changes and secure your consent prior to making use of your information in new ways.

THE INFORMATION WE COLLECT

The information we collect varies depending upon your activities when visiting our Site. We collect personal and contact information such as name, address, phone, fax, and/or email (“Personal Information”) you choose to provide to us in connection with requests for pricing or product information or other activities on the site. We also collect and store any other information you upload in the course of your activities on the site. Participation in these activities is completely voluntary; therefore, you can elect not to disclose, for example, your name or address by not participating in the activity.

In addition, we automatically collect site usage information from you when you visit our Site. Website usage information informs us about how you use and navigate the Site. We may collect information including the number and frequency of visitors on each web page, your Internet Protocol address, referring/exit pages, your operating system, date/time stamp, processor or device serial number, unique device identifier, clickstream data, the length of your stay, and the actions you take on the Site. We collect and store this information on an individual basis and in aggregate, or combined, form.

Certain pages of the Site use cookies or other means to track and store your information for the purposes described in this policy, and to allow us to recognize you as a user returning to the Site using the same computer and browser. A cookie is a tiny element of data that a website can send to your browser, which may then be stored on your hard drive so that our server can recognize when you return. You can erase or block this information from your computer at any time. If you reject cookies, you may still use our site, but your ability to use some areas of our site will be limited.

Do Not Track Signals. Some browsers have a “do not track” feature. We are not currently set up to respond to your browser’s do-not-track signal.

Analytics. To determine how many users visit our site, how often they visit this Site, and to better understand the areas of greatest interest to our visitors, we use a tool called “Google Analytics.” As a result of your visit to our Site, Google Analytics may collect information such as your domain type, your IP address and clickstream information. We do not combine the information collected through the use of Google Analytics with personally identifiable information. Google’s ability to use and share information

collected through Google Analytics about your visits to this Site is restricted by the Google Analytics Terms of Use and the Google Privacy Policy.

Ad Servers. As you browse our Site, advertising cookies will be placed on your computer to help us understand what products and services you are interested in. When you visit other sites, our display advertising partners let us show you retargeting advertising based on your interaction with our Site. Our ad partners do not collect personal information such as your name, email address, postal address, or telephone number. You may opt out of Google's use of cookies by visiting the Google advertising opt-out page: <http://www.google.com/settings/ads>.

Usage by Children. This Site is intended for use by adults. We do not knowingly collect information from children under the age of 13.

HOW WE USE THE INFORMATION WE COLLECT

We use the information we collect for the purposes stated at the point of collection, including providing you with the information, products and/or services you request. We may also use the information to contact you about new August & Joseph products or services from time to time.

Disclosure of information to third parties. We may share information we collect through this Site with our business partners, who may use that information to contact you regarding information you have requested or for other marketing purposes. We may also share aggregate and other non-personally identifiable information with our advertising partners.

California Privacy Rights. Pursuant to California Civil Code Section 1798.83, customers who are California residents can request certain information about the sharing of their own personal information with third parties for direct marketing purposes during the past year.
